## 500 Year Old Monument at St. Peter's Basilica rededicated

The funerary monument of Pope Innocent VIII (Giovanni Battista Cybo, 1484-1492) in St. Peter's Basilica was rededicated on Dec. 5 following a restoration undertaken with the support of the of Knights of Columbus.

The gold-plated bronze monument, crafted by Florentine artist Antonio del Pollaiolo, is considered a hallmark of Renaissance art. It was originally located in the ancient Basilica of St. Peter, and when the new St. Peter's Basilica was built, it was moved to its current location in 1621 where it has remained in recognition of its beauty and importance. It is the oldest funerary monument in the basilica today.

Cardinal Angelo Comastri presided at a short ceremony during which he presented Supreme Knight Anderson with a copy of the image of charity from the monument as a representation of the Order's first principle.

The renovation project is the latest active collaboration between the Knights and St. Peter's Basilica. In 1981, the Knights of Columbus sponsored the construction of a chapel dedicated to Sts. Benedict, Cyril, and Methodius, patron saints of Europe, in the Vatican Grottoes.

The following year, the organization funded the renovation and expansion of the adjacent chapel, dedicated to Our Lady of Czestochowa.

In 1985, the Knights of Columbus sponsored another major restoration project – the cleaning and conserving the 32,000 square feet of the façade of St. Peter's Basilica, as well as the famous statutes of St. Peter and St. Paul at the foot of the steps leading up the basilica.

Other notable projects sponsored by the Knights are the structural repairs to the roof of the Blessed Sacrament Chapel, as well as the repair of mosaics in the chapel vault. For the of the Jubilee Year 2000, the K of C funded the restoration of St. Peter's atrium and Holy Door, a task requiring more than 100 craftsmen.

In 2002 the organization supported the restoration of artwork in the grottoes of St. Peter's Basilica, and in 2007, marking its 125 anniversary, the Knights of Columbus funded the restoration of the funeral monument of Pope Sixtus IV – also crafted by Antonio del Pollaiolo, the same sculptor who created Pope Innocent VIII's tomb.

#### **HOW'S THE DIFFERENCE?**

Having been in the business for a long time, I have heard the arguments against buying permanent, cash value life insurance. For years, others — temporarily popular talking heads who make a name for themselves by dispensing bad advice — have tried to define whole life insurance. I bought my first whole life policy a long time ago, and what I hear, and what I see happening in my policy, are worlds apart.

For the record, there is nothing wrong with term insurance. We have a great term product that will provide coverage, for a limited term, at a very attractive price.

But the most popular myth these experts talk about is avoiding cash value (permanent) insurance, and "buying term and investing the difference" to achieve the same result. The theory is that you insure your life at a much lower premium cost (term insurance), take the difference between that premium and the higher whole life premium and invest it yourself. Some companies even have small funds they manage into which you can place that "difference." Perhaps you know someone who has followed this advice and decided to "buy term and invest the difference." I wonder how the difference is doing.

My guess is not so good. A couple of things could have happened.

First, most people never get around to investing the difference. Although it sounds good in theory, actually diverting that cash hardly ever happens. There are lots of places or your money to go, and the "buy term and invest the difference" enthusiasm dies quickly.

There are a few people who are actually disciplined enough to really invest the difference. And, if they are like most investors, it's been a difficult ride. The "difference" isn't making much of a difference.

I can tell you that every time I look at my whole life policy, it increases in value. It has a nice positive internal rate of return and, more importantly, will take care of my family if

something should happen to me. Guaranteed. I decided to let the Knights of Columbus invest my difference for me, and it's working out quite nicely.
